SERVICE & HOSPITALITY

It is your duty as an intern to serve campers, guests, staff, and other interns with a welcoming attitude. Camp guests should be your number one priority.

- *Encourage a hospitable environment by making VFC feel like a home away from home.*

- *Interact with guests and staff in a friendly manner*
- *Look for ways to make others feel welcome and appreciated.*
- *Ask to help others and be accommodating to their needs*

FOSTERING SPIRITUALITY

It is your duty as an intern to lead with spiritual confidence and knowledge that is consistent with the VFC mission statement. Express your faith through actions of forgiveness, service, love, grace, honesty, and stewardship.

- *Pursue personal spiritual growth through daily Bible study and prayer*
- *Lead small or large group Bible studies, worship, and prayer*
- *Attend and participate with campers in all scheduled services and devotions*

MENTORSHIP

It is your duty as an intern to teach and instruct campers in ways that are consistent with the VFC missions statement. Be a willing source of influence, guidance, and direction to those who are younger and in need.

- *Teach and lead in singing or Bible study*
- *Share your salvation story with campers*
- *Demonstrate a knowledge of the plan of salvation and how to lead someone to the Lord*

HEALTH & SAFETY

It is your duty as an intern to understand and practice safety and emergency procedures. Be prepared to accommodate campers with allergies, dietary restrictions, physical disabilities, emotional or behavioral problems, etc.

- *Review the list of campers with special needs*
- *Report all camper illnesses and injuries immediately*
- *Report all potentially unsafe conditions around the VFC property*

COMMUNITY

It is your duty as an intern to take responsibility for camp and personal property; as well as to be present and on time for staff meetings, services, and scheduled activities.

- *Interact and engage with campers throughout the day and during meals*
- *Listen actively when campers open up to you by sharing related experiences*
- *Encourage campers to try new experiences and overcome fears.*

ADHERENCE TO POLICY

It is your duty as an intern to dress according to the VFC intern dress code. The camp will also provide VFC t-shirts and polos that may be worn at anytime.

- *Men must wear shorts and t-shirts during the day; slacks and a polo during evening services*

- *Ladies must wear knee-length shorts or skirts/dresses during the day; knee-length skirts/dresses during evening services*
- *Swim attire should be modest. No bikinis or mid-riff swim tops for ladies*

TASK COMPLETION

It is your duty as an intern to willingly perform a wide variety of duties and help wherever or whenever it is needed. Fulfill tasks assigned by VFC leaders in a timely and complete manner.

- *Turn off lights, pick up trash, return equipment to where it belongs, etc.*
- *Be aware of general cleaning and property/ building maintenance at the beginning and end of the day*

- *Be willing to rotate assignments with other staff members*
- *Be willing to work retreats, weekends, and a flexible schedule*
- *Be willing to take time off when there are more staff members necessary for the number of campers registered*
